# SCORECARD

For the 118<sup>th</sup> Congress

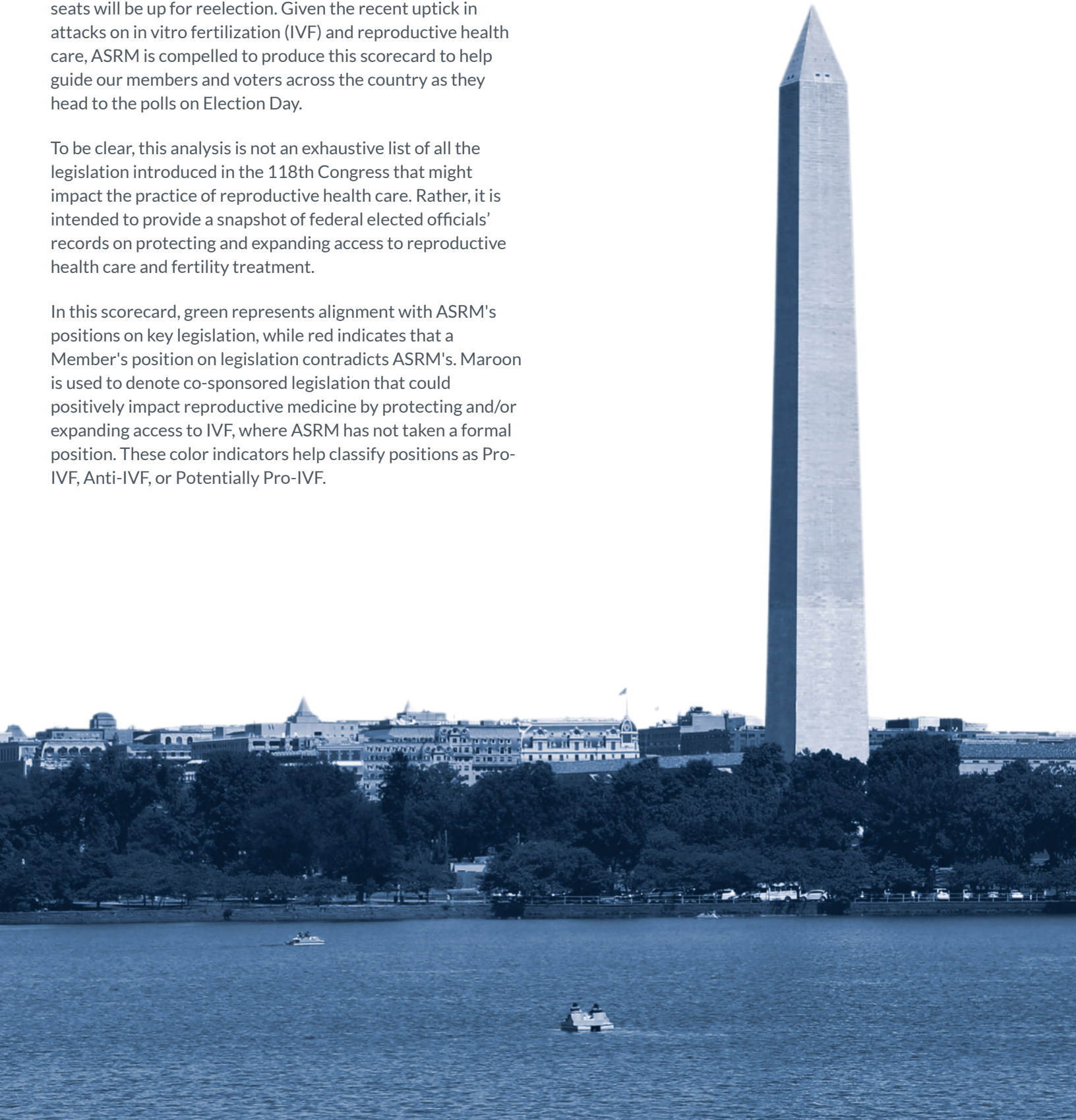




On November 5, 2024, all 435 House seats and 33 Senate seats will be up for reelection. Given the recent uptick in attacks on in vitro fertilization (IVF) and reproductive health care, ASRM is compelled to produce this scorecard to help guide our members and voters across the country as they head to the polls on Election Day.

To be clear, this analysis is not an exhaustive list of all the legislation introduced in the 118th Congress that might impact the practice of reproductive health care. Rather, it is intended to provide a snapshot of federal elected officials' records on protecting and expanding access to reproductive health care and fertility treatment.

In this scorecard, green represents alignment with ASRM's positions on key legislation, while red indicates that a Member's position on legislation contradicts ASRM's. Maroon is used to denote co-sponsored legislation that could positively impact reproductive medicine by protecting and/or expanding access to IVF, where ASRM has not taken a formal position. These color indicators help classify positions as Pro-IVF, Anti-IVF, or Potentially Pro-IVF.



# GUIDE TO IVF SENATE LEGISLATION

## #1: S. 4381, Right to Contraception Act

Introduced by Sens. Ed Markey (D-MA), Mazie Hirono (D-HI), and Tammy Duckworth (D-IL), the Right to Contraception Act would guarantee the legal right for individuals to get and use contraception and for health care providers to provide contraception. It would prohibit the federal government from administering, implementing, or enforcing any law, rule, regulation, standard, or other provision that would prohibit or restrict the sale, provision, or use of contraception. Further, the legislation would allow the Department of Justice (DOJ), providers, and individuals harmed by restrictions on contraception access to go to court to enforce these rights.

**ASRM supports this legislation.**

A floor vote was held on June 5, 2024.

## #2 & 3: S. 4445, Right to IVF Act

Championed by Sens. Duckworth, Patty Murray (D-WA), and Cory Booker (D-NJ), the Right to IVF Act would establish an enforceable nationwide right to receive, provide, or cover IVF services and expand insurance coverage for fertility care for servicemembers, veterans, and federal employees and under employer-sponsored and other public insurance plans.

**ASRM supports this legislation.**

Roll call votes were held on June 13, 2024 and September 17, 2024.

## #4: S. 4554, Reproductive Freedom for Women Act

Introduced by Sens. Murray, Chuck Schumer (D-NY), Tammy Baldwin (D-WI), Laphonza Butler (D-CA), Maria Cantwell (D-CA), Catherine Cortez Masto (D-NV), Duckworth, Kirsten Gillibrand (D-NY), Maggie Hassan (D-NH), Hirono, Amy Klobuchar (D-MD), Jacky Rosen (D-NV), Jeanne Shaheen (D-NH), Tina Smith (D-MN), Debbie Stabenow (D-MI), and Elizabeth Warren (D-MA), the Reproductive Freedom for Women Act is a sense of Congress legislation expressing support for access to abortion and other reproductive health care after the *Dobbs v. Jackson* decision and the overturn of the protections enshrined in *Roe v. Wade*.

**ASRM supports this legislation.**

A floor vote was held on July 10, 2024.

## #5: S. 1262, Family Building FEHB Fairness Act

Introduced by Sen. Duckworth, the Family Building FEHB Fairness Act would require carriers under the Federal Employees Health Benefit (FEHB) Program, the largest employer-sponsored health insurance plan in the world, to cover IVF and assisted reproductive technology (ART).

**ASRM supports this legislation.**

The legislation has been referred to the Senate Homeland Security and Governmental Affairs Committee (HSGAC).



# SENATE LEGISLATION *continued*

## **#6: S. 2213, Comprehensive Cancer Survivorship Act**

Led by Sens. Amy Klobuchar (D-MN) and Ben Cardin (D-MD), the Comprehensive Cancer Survivorship Act would establish Medicaid coverage for fertility preservation services and treatment for infertility for cancer patients, in addition to long-term storage costs for reproductive genetic materials.

**ASRM supports this legislation.**

The legislation has been referred to the Senate Finance Committee.

## **#7: S. 2386, Access to Infertility Treatment and Care Act**

Championed by Sen. Booker, the Access to Infertility Treatment and Care Act would require most private health insurance plans, as well as plans offered by the FEHB, Medicaid, TRICARE, ERISA, and the Department of Veterans Affairs (VA), to cover fertility treatments. It would also require coverage of fertility preservation services for individuals who undergo a medically necessary procedure that may cause infertility.

**ASRM supports this legislation.**

The legislation has been referred to the Senate Health, Education, Labor, and Pensions (HELP) Committee.

## **#8: S. 2801, Veteran Families Health Services Act**

Introduced by Sens. Murray and Duckworth, the Veteran Families Health Services Act would expand the fertility treatments and family building services covered under servicemembers' and veterans' health benefits to include the option for individuals to cryopreserve their gametes ahead of deployment to a combat zone and IVF for servicemembers and veterans who are unable to conceive without assistance.

**ASRM supports this legislation.**

On March 12, 2024, Sen. Murray sought unanimous consent on the Senate floor to pass the legislation. Sen. James Lankford (R-OK) blocked the legislation. The legislation remains pending before the Senate Veterans' Affairs Committee.



# SENATE LEGISLATION *continued*

## #9: S. 3612, Access to Family Building Act

Championed by Sens. Duckworth and Murray, the Access to Family Building Act would establish a statutory right for an individual to access ART, such as IVF, and for a health care provider to provide ART services. Additionally, it would establish an individual's statutory right regarding the use or disposition of their reproductive genetic materials. The legislation would allow DOJ to pursue civil action against any state, government official, individual, or entity that violates protection in the legislation and create a private right of action for individuals and health care providers in states that have limited access to ART.

### ASRM supports this legislation.

On February 28, 2024, Sen. Duckworth sought unanimous consent on the Senate floor to pass the legislation. Sen. Cindy Hyde-Smith (R-MS) blocked the legislation. The legislation remains pending consideration by the Senate HELP Committee.

## #10: S. 4368, IVF Protection Act

Introduced by Sens. Ted Cruz (R-TX) and Katie Britt (R-AL), the IVF Protection Act would render states ineligible to receive Medicaid funding if they have enacted an outright ban on access to IVF. The legislation does not compel any person or organization to provide IVF and explicitly permits states to enact further regulations on IVF.

### ASRM opposes this legislation's approach which threatens to cut off Medicaid funds, potentially punishing vulnerable patients, while doing little to protect fertility care.

On June 12, 2024, Sen. Britt sought unanimous consent to pass the legislation on the Senate floor. Sen. Murray blocked the legislation. On September 17, 2024, Sen. Cruz again sought unanimous consent to pass the legislation, but it was again blocked by Sen. Murray. The legislation remains pending before the Senate Finance Committee.

## #11: S. 4533, RESTORE Act

Championed by Sens. Hyde-Smith and Lankford, the Reproductive Empowerment and Support Through Optimal Restoration (RESTORE) Act would promote educational tools for women seeking information about reproductive health conditions and restorative reproductive medicine and provide training opportunities for medical professionals to learn how to better diagnose and treat reproductive health conditions. It would direct the Department of Health and Human Services (HHS) to conduct data collection and implement ongoing reports to assess the access women have to reproductive medicine and infertility care and leverage existing opportunities in Title X and the HHS Office of Population Affairs to promote medical training to help women with reproductive health conditions and infertility.

### ASRM opposes this legislation which could steer patients toward suboptimal care.

The legislation was referred to the Senate HELP Committee.

## #12: S. 4771, IVF with HSAs Act

Introduced by Sen. Rick Scott (R-FL), this legislation would decouple Health Savings Accounts (HSAs) from high-deductible health plans and double the current contribution limits on HSAs from \$4,300 to \$8,600 for individuals and \$8,550 to \$17,100 for families with the intent of helping families better plan and pay for medical expenses, like IVF.

### ASRM has not taken a position on this legislation.


On September 16, 2024, Sen. Scott (R-FL) sought unanimous consent to pass his legislation on the floor but was blocked by Sen. Ron Wyden (D-OR). The legislation is pending before the Senate Finance Committee.

## #13: S. Res. 574, Expressing Support for Starting and Growing a Family Through IVF


Led by Sen. Rick Scott (R-FL), this legislation expresses support for starting and growing a family through IVF.


### ASRM has not taken a formal position on this legislation.

The legislation was referred to the Senate HELP Committee.

# GUIDE TO IVF HOUSE LEGISLATION

## #1: H.R. 431, Life at Conception Act

Introduced by Rep. Alex Mooney (R-WV), the Life at Conception Act defines the term “human being” to include “all stages of life, including the moment of fertilization, cloning, or other moment at which an individual member of the human species comes into being.”

**ASRM opposes this legislation because it threatens access to needed reproductive care.**

The legislation has been referred to the House Judiciary Committee.

## #2: H.R. 544, Veterans Infertility Treatment Act

Championed by Rep. Julia Brownley (D-CA), the Veterans Infertility Treatment Act would require fertility care, including ART, to be included as part of the medical services provided by the VA to any veteran and/or partner who needs infertility care to achieve a pregnancy. The legislation would allow for up to three successful pregnancies or six attempted IVF cycles. Additionally, this legislation would codify the repeal of the ban on the use of donor gametes and embryos.

**ASRM supports this legislation.**

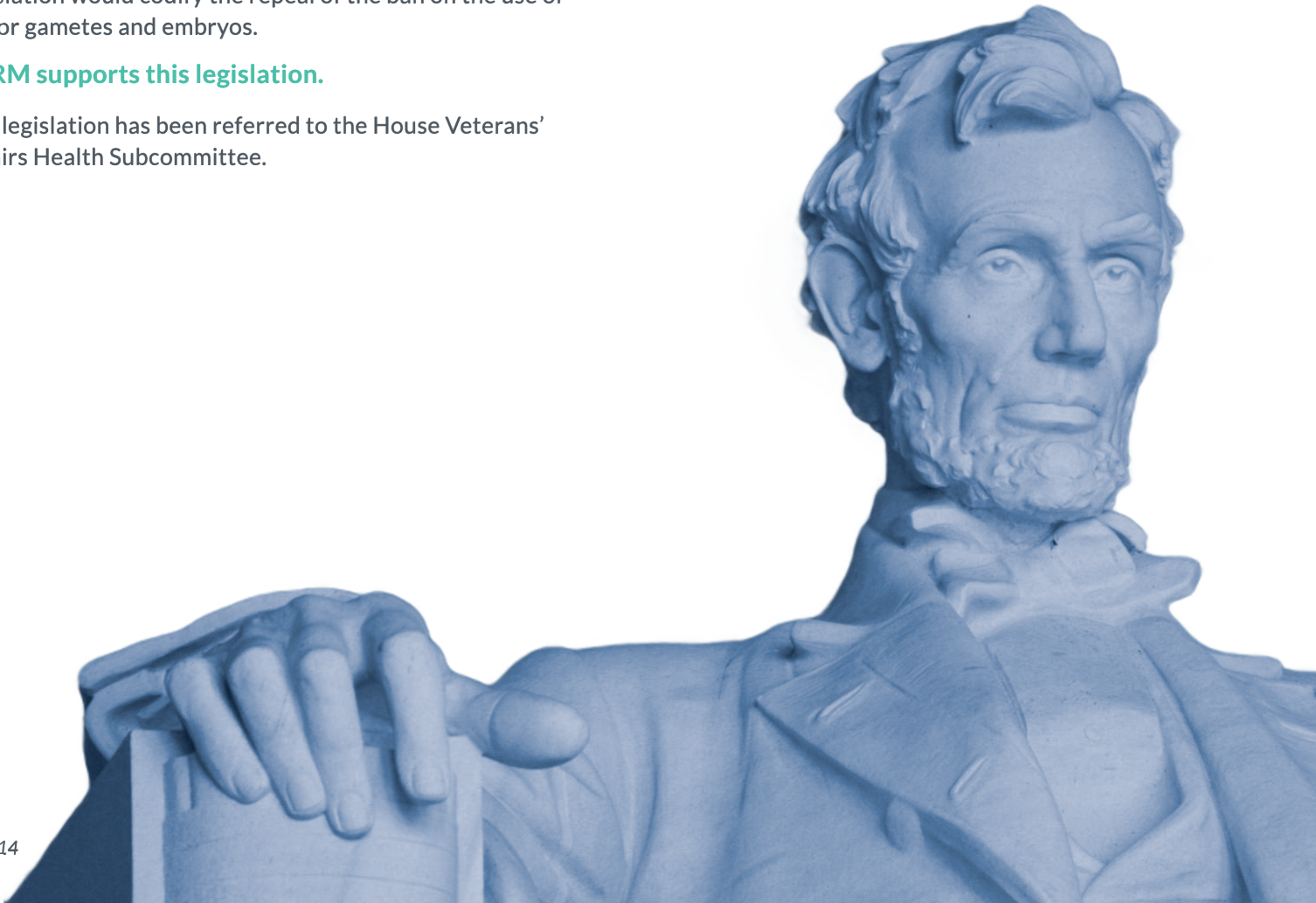
The legislation has been referred to the House Veterans' Affairs Health Subcommittee.

## #3: H.R. 2828, Family Building FEHB Fairness Act

The House companion to S. 1262, Rep. Gerry Connolly's (D-VA) Family Building FEHB Fairness Act would require carriers under the FEHB Program to cover IVF and ART.

**ASRM supports this legislation.**

The legislation has been referred to the House Oversight and Accountability Committee.





# HOUSE LEGISLATION *continued*

## **#4: H.R. 4121, Right to Contraception Act**

Introduced by Rep. Kathy Manning (D-NC) as the House companion to S. 4381, the Right to Contraception Act would guarantee the legal right for individuals to get and use contraception and for health care providers to provide contraception. It would prohibit the federal government from administering, implementing, or enforcing any law, rule, regulation, standard, or other provision that would prohibit or restrict the sale, provision, or use of contraception. Further, the legislation would allow DOJ, providers, and individuals harmed by restrictions on contraception access to go to court to enforce these rights.

**ASRM supports this legislation.**

The legislation has been referred to the House Energy and Commerce Health Subcommittee.

## **#5: H.R. 4363, Comprehensive Cancer Survivorship Act**

The House companion to S. 2213, the Comprehensive Cancer Survivorship Act would establish Medicaid coverage for fertility preservation services and treatment for infertility for cancer patients, in addition to long-term storage costs for reproductive genetic materials. The legislation was introduced by Reps. Debbie Wasserman Schultz (D-FL), Brian Fitzpatrick (R-PA), and Mark DeSaulnier (D-CA).

**ASRM supports this legislation.**

The legislation has been referred to the House Energy and Commerce Health Subcommittee, the House Ways and Means Committee, and the House Education and the Workforce Committee.

## **#6: H.R. 4391, Equal Access to Reproductive Care Act**

Championed by Reps. Adam Schiff (D-CA), Judy Chu (D-CA), and Brownley, the Equal Access to Reproductive Care Act would modernize the federal tax code to allow equal treatment to those using ART and surrogacy arrangements regardless of sexual orientation, gender identity, and ability status. This would allow all LGBTQ individuals and families to claim IVF medical expenses as tax deductions.

**ASRM supports this legislation.**

The legislation has been referred to the House Ways and Means Committee.

## **#7: H.R. 4731, Access to Infertility Treatment and Care Act**

Introduced by Rep. Rosa DeLauro (D-CT) as the House companion to S. 2386, the Access to Infertility Treatment and Care Act would require most private health insurance plans, as well as plans offered by the FEHB, Medicaid, TRICARE, ERISA, and the VA to cover fertility treatments. It would also require coverage of fertility preservation services for individuals who undergo a medically necessary procedure that may cause infertility.

**ASRM supports this legislation.**

The legislation has been referred to the House Energy and Commerce Health Subcommittee, the House Education and the Workforce Committee, the House Ways and Means Committee, the House Oversight and Accountability Committee, the House Veterans' Affairs Committee, and the House Armed Services Committee.

# HOUSE LEGISLATION *continued*

## **#8: H.R. 5492, Veteran Families Health Services Act**

The House companion to S. 2801, Rep. Rick Larsen's (D-WA) Veteran Families Health Services Act would expand the fertility treatments and family building services that are covered under servicemembers' and veterans' health benefits to include the option for individuals to cryopreserve their gametes ahead of deployment to a combat zone and IVF for servicemembers and veterans who are unable to conceive without assistance.

### **ASRM supports this legislation.**

The legislation has been referred to the House Veterans' Affairs Health Subcommittee and the House Armed Services Committee.

## **#9 & 10: H.R. 7056, Access to Family Building Act**

Introduced by Rep. Susan Wild (D-PA) as the House companion to S. 3612, the Access to Family Building Act would establish a statutory right for an individual to access ART, such as IVF, and for a health care provider to provide ART services. Additionally, it would establish an individual's statutory right regarding the use or disposition of their reproductive genetic materials. The legislation would allow DOJ to pursue civil action against any state, government official, individual, or entity that violates protection in the legislation and create a private right of action for individuals and health care providers in states that have limited access to ART.

### **ASRM supports this legislation.**

While the legislation has been referred to the House Energy and Commerce Health Subcommittee, Rep. Wild has filed a discharge petition to try to force a vote on the House floor.

## **#11: H.R. 7669, Right to Try IVF Act**

Led by Rep. Anna Paulina Luna (R-FL), the Right to Try IVF Act would make states ineligible for funding through the State Maternal and Child Health Services Block Grant program if a state prohibits a licensed physician from performing IVF.

### **ASRM opposes this legislation because it threatens to withhold funding for a vulnerable population and does not meaningfully prohibit restrictions on IVF.**

The legislation has been referred to the House Energy and Commerce Health Subcommittee.

## **#12: H.R. 8821, HOPE with Fertility Services Act**

Championed by Reps. Lori Chavez-DeRemer (R-OR), Zach Nunn (R-IA), Wild, and Wasserman Schultz, the HOPE with Fertility Services Act would amend ERISA to require private health plans to cover care for infertility due to a diagnosed disease or physical ailment that prevents the bringing of child to full term live birth, unexplained infertility for couples who cannot conceive a child after trying for at least 12 consecutive months, and iatrogenic infertility.

### **ASRM supports this legislation.**

The legislation has been referred to the House Education and the Workforce Committee.

# HOUSE LEGISLATION *continued*

## #13: H.R. 8855, Life Act

Introduced by Rep. Bob Good (R-VA), the Life Act would amend Title 18 of US Code to make it a federal crime for a licensed medical professional who accepts federal funds, including from Medicaid, the Children's Health Insurance Program (CHIP), Indian Health Service (IHS), VA, TRICARE, and Title X to perform or prescribe an abortion at any point after fertilization. The legislation would also prohibit federally regulated health plans, including ERISA, Affordable Care Act (ACA), and FEHB plans from covering abortions.

**ASRM opposes this legislation as it could result in suboptimal care for patients and jeopardize access to fertility treatment.**

The legislation has been referred to the House Energy and Commerce Committee, House Judiciary Committee, House Natural Resources Committee, House Ways and Means Committee, and House Oversight and Accountability Committee.

## #14: H.R. 8869, IVF Protection Act

Led by Reps. Scott Perry (R-PA) and Nancy Mace (R-SC), the IVF Protection Act, the House companion to S. 4368, would render states ineligible to receive Medicaid funding if they have enacted an outright ban on access to IVF. The legislation does not compel any person or organization to provide IVF and explicitly permits states to enact further regulations on IVF.

**ASRM opposes this legislation's approach to threatening to cut off Medicaid funds, potentially punishing vulnerable patients, while doing little to protect fertility care.**

The legislation has been referred to the House Energy and Commerce Committee.

## #15: H.R. 9141, IVF with HSAs Act

Introduced by Rep. Kat Cammack (R-FL) as the House companion to S. 4771, the IVF with HSAs Act would decouple Health Savings Accounts (HSAs) from high-deductible health plans and double the current contribution limits on HSAs from \$4,300 to \$8,600 for individuals and \$8,550 to \$17,100 for families with the intent of helping families better plan and pay for medical expenses, like IVF.

**ASRM has not taken a position on this legislation.**

The legislation has been referred to the House Ways and Means Committee.

## #16: H.R. 9269, IVF Access and Affordability Act

Introduced by Reps. Mike Lawler (R-NY) and Marc Molinaro (R-NY), the IVF Access and Affordability Act would create a tax credit - \$20,000 for individuals and \$40,000 for couples filing jointly - for ART expenses.

**ASRM has not taken a position on this legislation.**

The legislation has been referred to the House Ways and Means Committee.

## #17: H.R. 9643, Right to IVF Act

Led by Rep. Wild, the Right to IVF Act is the House companion to S. 4445. The legislation would establish an enforceable nationwide right to receive, provide, or cover IVF services and expand insurance coverage for fertility care for servicemembers, veterans, and federal employees and under employer-sponsored and other public insurance plans.

**ASRM supports this legislation.**

The legislation has been referred to the House Energy and Commerce Committee, House Veterans' Affairs Committee, House Armed Services Committee, House Education and the Workforce Committee, House Ways and Means Committee, and House Oversight and Accountability Committee.

## **#18: H.R. 9479, Legislation to Amend the Internal Revenue Code of 1986 to Establish a Refundable Credit for Expenses Incurred for IVF**

Introduced by Rep. Mariannette Miller-Meeks (R-IA), this legislation would establish a fully refundable tax credit for IVF-related medical expenses, including transportation to and from services, egg retrievals, transfers, counseling, lab fees, medications, and ultrasounds, up to a lifetime benefit of \$30,000.

**ASRM has not taken a position on this legislation.**

The legislation has been referred to the House Ways and Means Committee. Votes shaded in gray indicate that the Representative cosponsored the legislation.

## **#19: H. Res. 1037, Providing the Sense of the House that IVF is Necessary for Women who Cannot Conceive Naturally**

Championed by Reps. Chavez-DeRemer, Michelle Steel (R-CA), and Juan Ciscomani (R-AZ), this legislation expresses support for access to and use of IVF treatments across the U.S., states a commitment to policies that enable families to grow and thrive, and recognizes life as precious.

**ASRM has not taken a position on this legislation.**

The legislation has been referred to the House Energy and Commerce Health Subcommittee. Votes shaded in gray indicate that the Representative cosponsored the legislation.

## **#20: H. Res. 1043, Expressing Support for Continued Access to Fertility Care and ART, Such as IVF, in Light of the Supreme Court of Alabama's Ruling that has Jeopardized Access to IVF and Other ART**

Introduced by Reps. Mace, David Schweikert (R-AZ), Jeff Van Drew (R-NJ), Anthony D'Esposito (R-NY), Don Bacon (R-NE), and Jen Kiggans (R-VA), this legislation recognizes the prevalence of infertility and highlights the widespread use of ART. It calls on elected officials to reject proposals that would restrict access to IVF and to proactively pass legislation to protect access to fertility care.

**ASRM has not taken a position on this legislation.**


The legislation has been referred to the House Energy and Commerce Health Subcommittee. Votes shaded in gray indicate that the Representative cosponsored the legislation.


## **#21: H. Res. 1060, Expressing Support for Starting and Growing Families Through IVF**


Championed by Rep. Kat Cammack (R-FL) as the House companion to S. Res. 574, this legislation expresses support for starting and growing a family through IVF.
